- Provision of advice (including legal implications of policies and procedures) and management of legal issues pertaining to PCB, including those for the Pakistan Super League and other events organized by the PCB
- Dissemination of legal advisories within PCB, including those for Players and Player Support Personnel
- Identification and mitigation of legal / litigation risks to ensure that the PCB Constitution is being adhered to as well as applicable laws of the country
- Drafting Notices of Charge under the Anti-Corruption, Anti-Doping and Anti- Racism regulations of PCB, on athletes involved in corruption, doping and discrimination matters under the respective codes, and initiating appropriate legal proceedings against them
- Maintenance & administration of PCB's Panel of Advocates and Independent Adjudicators
- Identifying important issues, highlighting the same to the Executive Management and apprising PCB Departments of emerging legal trends from court decisions and offering advice to avoid unnecessary litigation in future, etc.
- Conducting inquiries, grievance redressal proceedings and personal hearings in disciplinary matters or in compliance of Court orders
- Liaising with external stakeholders, including the ICC, other cricket boards, government agencies as well as commercial partners and assisting in the development of strategies to implement PCB's vision and mission accordingly

### Governance

- Effectively planning and executing all PCB Board of Governor / Management Committee meetings, including preparation of the agenda, reports and other working papers
- Taking meeting minutes, facilitating the dissemination of action points arising from Board decisions and ensuring adherence to best corporate governance practices
- Maintaining and organizing the Board's records, ensuring easy accessibility and reference
- Liaising with the Board of Governors on behalf of the PCB Management, effectively representing the Chairman, Chief Executive Officer and Chief Operating Officer
